## **CITY MANAGER'S REPORT:**

- The Hudson Police Department had a complex challenge last week with the response to the multiple school threats. Chief Weir and the Officers of HPD did an excellent job of working with the School District, County, State and Federal Law Enforcement to manage and gain control of the situation.
- A serious sewer blockage and sinkhole across Howard Street between the Post Office and Promedica resulted in a major emergency engineering and construction operation over the past 10 days, resulting in a minor comprehensive reconstruction project. Repairs have been completed and the area is open and back to normal. It appears that the water main, which was under physical strain from an abandoned manhole structure above it, cracked and undermined the adjacent storm catch basin and the 15-foot tall brick sanitary sewer manhole, blocking the sewer line running west. The response involved DPW, WWTP, M&K Jetting, Mike Karafa from Jones & Henry Engineers, Bailey Construction, D&P Communications, Belson Asphalt and Tri-State Concrete. Old infrastructure was excavated and removed, and a new sewer line and concrete cast manhole was placed; laterals connected, new storm catch basins and lines laid, a new water main installed; and the site was filled and compacted, the road was paved; and new curb and gutter, driveway approaches and sidewalks constructed. This was a good example of a quick response and outstanding teamwork. The cost of this repair is likely to be above \$100,000.
- The November 5<sup>th</sup> election went very smoothly. City Clerk Jeaniene McClellan, Deputy Clerk Linda Cross and City Receptionist Kris Eschedor oversaw a great team of election workers led by Lynnette High, who manned the polls from before 6 a.m. to after 8 p.m. In addition to the re-election of Mayor Pro-Tem Daugherty and the election of previously-appointed Council member Pam Ely, the Initiated Marijuana Ordinance was rejected by voters with 129 votes in favor and 278 against. The 26.7% voter turnout percentage was the highest in the County.
- Further progress has been made on a few jobs at the Community Center, including repairs to the gas stove and the replacement of the broken opening mechanism on the main entrance.
- The crack-sealing work on Cadmus, South Munson and Steger Industrial Drive has been completed.
- Council Member Daugherty accompanied Air Specialist Jeff from AQC and City Manager around the City Office/Fire Station building to follow-up on the Volatile Organic Chemical readings and determined that the fresh air makeup valve has been stuck closed and a large gap near the return air duct in the fire bay was allowing fumes in the fire bay to recirculate into the office. Legacy Heating and DPW Superintendent Jay Best corrected these conditions and the air has markedly improved since.
