## REMINDER

**All Hudson City Residents and Persons who are employed within the Hudson City Limits:**

2013 Income Tax Returns are due to the City Offices by April 30th

Hudson PD will be tagging and towing if necessary, junk and abandon vehicles from private and public properties.



Sec. 19-123 (4)b

The term "junk automobiles" shall

include, without limitation any vehicle which is not licensed for use upon the highways of the State for a period in excess of ten days, and shall also include, whether licensed or not, any motor vehicle which is inoperative for any reason for a period in excess of ten days, provided that there is excepted from this definition unlicensed, but operative vehicles which are kept as stock in trade of a regularly licensed and established new or used automobile dealer.

Sec. 19-123(4)c

The term "abandon vehicle" shall include, without limitation, any vehicle which has remained on private property for a period of 48 continuous hours, or more, without the consent of the owner or occupant of the property, or for a period of 48 continuous hours or more after consent of the owner or occupant has been revoked.

Sec 19-157

Penalty

A person who violates Sec. 19-123 is responsible for a municipal civil infraction with a civil fine of not less than \$50.00 or more than \$500.00 plus cost and other sanctions for each infraction.

## Lawn Maintenance

Owners of occupied or unoccupied property must maintain their lawns. Grass, noxious weeds or other vegetation heights cannot exceed 8 inches. The City will mow the property and bill the property owner.



## All Dogs Must Be Licensed:

Several complaints have been received concerning barking dogs, loose dogs, and other matters regarding dogs. Dog owners must be aware that dogs are not allowed to run freely and must be secured. Dogs should not be permitted to disturb the peace by frequent barking, howling, or yelping. Dogs are not permitted to discharge excrement upon any private or public property. Dog owners must remove excrement from these areas immediately upon discharge. There is a 3 dog limit. It shall be unlawful to own or harbor more than 3 dogs, 6 months or older in the City limits. # City of Hudson Annual Spring Rubbish Pick-Up Saturday, April 19, 2014



All items for general pick-up must be at the side of the street by 7:00 a.m. on this day but no earlier than seven (7) days before the pick-up date. Items that **will not** be disposed of are: bricks, cement & concrete, vehicle tires, refrigerators (without a CFC sticker and/or the doors still remaining), acidic batteries, paint or stain cans, liquids of any type, large auto parts, TV's, microwaves, computer monitors or fluorescent bulbs. Limbs, boards, etc. must be cut into 4 ft. lengths & tied, items must not be heavier than something 2 people can lift, and plaster or items of loose nature must be placed in boxes or containers. *Please remember that if articles are placed at the curb after your street has been picked up, the crews will not return to that particular street. Refuse pick-up is for City of Hudson residents only. A penalty will be charged if rubbish from outside of the City is found being brought into the City.*

**As a reminder, any trash receptacle or recycle bin left at the roadside after 6:00 p.m. following the day of trash removal may be picked up by the Department of Public Works. You may call DPW at 448-6101 or City Hall at 448-8983 with any questions.**

### Reminder to City Residents:

The Department of Public Works will only pick up yard debris that has been placed in **paper biodegradable** bags. These bags are available at most stores for purchase. Any questions can be directed to the City Office.

### GARAGE SALE PERMITS

Ordinance No. 381.08. Effective May 31, 2008, all garage, yard, basement, etc. sales must have a permit which will be posted in a conspicuous place at all times during the sale. Sales shall be limited to 3 per year and not more than 7 consecutive days each with a minimum of 30 days between the last day and the first day of any sale. Garage Sale permits are *free*. This does not pertain to the city wide garage sales. Please call the city office for more information.
